



Maryland Legislative Session Report

May 2025



Legislative Victories



Climate

STRIDE Reform (Ratepayer Protection Act) (SB937)

- This bill will reduce gas companies' wasteful spending on pipelines, protecting Maryland residents from excessive utility bills and encouraging the transition to clean energy. It passed as part of a larger climate package, the Next Generation Energy Act.



Pre-K

Mixed Delivery Model Viability Act (HB1475)

- This bill requires the State Department of Education (MSDE) to study the pre-K grant system and make recommendations on ways to improve the system.
- Delegate Feldmark introduced this bill after our advocacy at our November action.



Immigrants' Rights

Maryland Values Act (HB1222)

- This bill will restrict federal immigration agents from accessing non-public areas within public schools, libraries, and state-funded facilities without a warrant.
- It will also require state agencies to create policies to not sell or share people's personal data.

Legislative Next Steps



Housing and Renters' Rights

- Housing for Jobs and Good Cause Eviction, which we supported, did not pass.
- We will follow up with key state officials, including the Maryland Comptroller, Secretary of Housing, and Attorney General, to advance housing opportunities and tenants' rights.
- We'll also continue to strengthen our relationships and collaborate with legislators on these and other issues.



Legislative Highlight: Ratepayer Protection Act

This bill we helped pass this year will:

- Lower everyday people's gas bills
- Reduce the use of dirty natural gas that harms people's health
- Reduce pollution in the state

Increasing Our Statewide Impact

ACT, AIM, and PATH joined forces to advocate together as the **Maryland Just Power Alliance** this legislative session. We announced our powerful statewide coalition at a packed action in November with 700 people and 15 elected officials.



Over 200 people joined us for our **Annapolis Advocacy Days** to meet with their legislators at the Maryland State House. Legislators were impressed by our turnout and the personal stories we shared.



Being part of the state legislative campaign was a way for me and my congregants to channel our feelings into action during this difficult time. I appreciate this interfaith organization because we all show up for different reasons based on our faith traditions and values, but ultimately with the goal of justice in our communities.
